Artist assumes full responsibility for any loss or damage to said artwork due to fire, theft, spoilage, criminal activity, negligence or any other reason during the time artwork is in the possession of Kudzu or one of the business displaying said artwork.

It is agreed and understood that upon the presentation to the gallery and/or various business displaying said artwork of cash or check that the artwork will be immediately released to the purchaser. Kudzu agrees to then pass the check or cash received on to the artist. Kudzu assumes no responsibility if the check does not clear or if for any reason a claim arises between the artist and the purchaser or if any criminal act occurs. Kudzu's involvement in the transaction ends once Kudzu presents the check or cash to the artist.

Works on canvas must be framed unless “Gallery Wrapped” (no visible staples). All other two-dimensional works must be framed.

Include your name and the title of the work on the back of your artwork. Your artwork must be accompanied by a fully executed Exhibition Form that lists each piece of art.

Eligibility:

- Current members of KAZ only.
- Submissions must be less than two years old.
- Only works not previously accepted at KAZ shows are eligible for submission.

Exhibits are juried. Work not accepted must be picked up by the artist within two weeks of notification by KAZ. Works accepted in the exhibit must remain in the exhibit until the exhibit ends unless the work is sold; work may be removed immediately by purchaser.

Jury fees and/or exhibit fees may be charged and will be stated in the exhibit-specific documents.

Sales: Kudzu Art Zone, Inc. will accept checks payable to the artist for the price shown on the artwork submission form. Kudzu will obtain the buyer's name, address telephone number and driver's license number. Kudzu is not responsible for bad checks. If you prefer to handle the sale yourself, please do not enter a price on the exhibition form; instead, please provide appropriate contact information such as your business card. All artwork must remain in the exhibit until the exhibit ends.

Commission on Sales: Artist must pay a 10% commission to the venue host. A 10% donation to Kudzu is also suggested.

Insurance: Kudzu Art Zone, Inc. does not carry insurance coverage for damages or losses to artworks, materials, or other items placed in the exhibit.

Transportation to and from Kudzu Art Zone will be provided by the artist.

Framing requirements:

- No sawtooth hangers
- Screw eyes 1/3 down from the top
- Use picture wire
- Top of picture wire must be at least 2" from top
- Write your name and title of work on the back
